- At what point do we ask a trusted servant to no longer serve guidelines needed about what qualifies to disqualify
  - Motion passes to amend guidelines to the following verbiage:
  - Any Trusted Servant of the Sonoma Online NA Group may be removed from their position for non-compliance after direct communication from a business meeting delegate who states the concerns and reasons that they have been removed. Non-compliance includes, but is not limited to:
  - Loss of abstinence from drugs.
  - $\circ$  Failing to perform the duties of the position.
  - Three consecutively missed meetings with no communication or a pattern of absences over time.
  - The Sonoma Online NA Group may remove any trusted servant for any reason it deems appropriate by a 2/3 vote.
- Zoom log in issues??? 3/4 different meeting IDs that use the Zoom Account; Noon and the 7pm meeting log in says "Meeting is already in progress" sporadically

Whenever you cannot start your meeting because Zoom is showing another meeting is "Already in progress" or "The Host as another meeting in progress", log into the prior noon or 7pm meeting as appropriate and "End the Meeting for All", then go back and log into your scheduled meeting.



- Tuesday noon needs to be filled ASAP; Jason needs to step down for health reasons effective 1/31/2023 (announcing at that meeting that he's giving up the commitment) – Monica offered to take over
- Transfer of commitment from old to new Host?
  - o Add "training " section into official guidelines?
  - o Willing to train replacement Host when transferring commitment?
  - Create a new position as "Service Trainer"; 1 year clean; having served as Host and Co-Host for a full term; has the ability to understand Zoom the way this group uses it and knowledge of how to Host and Co-Host a meeting on Zoom; knowledge of the Traditions and Concepts; 1 year term
  - Kelly makes a motion to create position; Chelie seconds; motion passes
  - Kelly nominates Chelie to fulfill the position; passes
