Old Business:

- Flyer to notify people of meetings – Jeff volunteers (TABLED TILL JUNE)

New Business:

- Co-host: Monday Noon co-host has only shown up 2 of 6 times (approximately). Trusted Servants attempted to contact to notify and see how person is doing. No response. Motion to find another co-host. (passed unanimously).
- If trusted servant has two consecutive unexcused absences (no show, no call) we will make an effort to reach out to the trusted servant to inform them we will be putting the position up for another person to fulfill it and remind them that we want them to come back to the meeting, but need our commitments filled.
 - Are we being inclusive as a group by doing this. We need to be doing this as a group and not put the meeting secretary in the position of handling it on their own. We need a

process so the person who no longer has the position knows it was a group decision and not just the meeting secretary- this supports our secretaries.

- Co-host/Relapse: Our group's practice has been that we do not waive clean time at the meeting itself, but that if they would like to keep position they must attend the business meeting and ask that we waive clean time.
 - Does the person need to be in attendance at the business meeting or not be in attendance at the business meeting to make a motion to waive clean time?
 - If the position is important to the person they would show up to the business meeting. Group conscience is that they MUST show up at the business meeting.
 - What happens if they relapse just after the business meeting? That could be 3 weeks of no co-host. (No guarantee that we will waive clean time anyway)
 - Reach out to other members to get help with vacant position during interim.
- Secretary: Need new business meeting Secretary (TABLED)
- ASC Motions: Flyer Guidelines (Vote = YES unanimous) Motion to remove GSR Coordinator vote (Vote = Yes unanimous)
- Meeting Format Scripts Status Update:
 - Difficult with the split between the 3 readings
 - Frustrating to have them split.
 - Messes up the flow
 - Maybe consolidate readings and have the newcomer welcome at the end of the script.
 - Group conscience by consensus is to: consolidate readings and have the newcomer welcome at the end of the script. “
