We approved adding pdf. files of official NA pre-meeting (card) formats to Sonoma Online website.

 How do we handle position holders, especially hosts and co-hosts, who are not fulfilling the positions. We had a newer member as host unsure how to handle a co-host not showing up regularly:

The group re-stated our long-standing policies: (1), that position holders must show up to their commitments each week, timely, or have their position covered by another qualified member (in cases where they might occassionally be absent. (2), that, especially with the host and co-host positions, the requirements of those positions must be performed as required as these are very important to the functionality of the meetings. (3) in cases where folks either aren't showing up, or not performing their duties correctly, we as a group will provide them reasonable opportunities to do this, but, will advice the person at such time as it becomes clear they are not able to hold the position for failure to meet the basic requirements. (4), if for any reason a host or co-host does not feel comfortable confronting their host or co-host with information that they are not fullfilling their requirement(s), they should bring the matter to the group. The group will then decide how to handle relaying the information.
