Old Business:

I. Group Phone List

The phone list we have now is: (a) impractical to maintain and access (many clicks on Service page culminating in a password which no one knew. The practical importance of an easily available and updatable phone list for Trusted Servants was discussed. In It was proposed that we create a Phone List file on Google Docs. Two questions arose (1) how easy is this using the Sonoma Online G-mail account? (2) Who should maintain this list, should we create a phone list position? Some concerns arose under how we maintain security on Google Docs with people's numbers and email addresses, as well as the same problem we currently have with ease of use. The group voted to re-visit the issue in July.

Discussion was had about security with having a phone list posted where the public can access it. On-going discussion regarding; (a) ease-of-use, (b) security of member's name and phone number via web accessibility, (c), whether or not we want to create a phone list maintenance position. Motion was made & passed to discuss this further at the August business meeting.

Motion was made to make a new trusted servant position called "Phone List Coordinator". The individual elected would create and maintain a phone list/contact info of trusted servants. Motion passed.

Discussed establishing guidelines for new service position; (a) clean time requirement (b) how long commitment will last (c) how the info will be collected and distributed. Discussion tabled until September business meeting.
